TITLE: "TURNING" provision for Cumbrian Schools

Executive Summary:

The Office of the Police and Crime Commissioner is looking to support educating young people about Domestic Abuse within adolescent relationships. Funding the DVD and training resources, "TURNING", will build on the benefits and education gained through an impactful resource to compliment the Turning the Spotlight "Step Up" perpetrator programme. The request is for funding to purchase the resources which will :

- Provide a county wide available resource for a wide range of school audiences and attendance centres, including looked after children and where local risks have been identified.
- Add value to current services provided by the Safer Cumbria structure around addressing Domestic Abuse, including engaging partners in the education process.
- Build in learning that can be passed on through schools and other partners that will live on.

Recommendation:

The Commissioner is asked to provide a total of £5,000 to be allocated to provide:

- Produced in association with' credit on the film and in the supporting, printed training materials
- 30+ copies and associate learning tools
- Perpetual, lifetime licence



1. Introduction & Background

1.1

Tcd's production of "TURNING" is a sequel to their powerful production "Leaving". It is an innovative and powerful production highlighting the very serious and emotional issue of domestic abuse in the relationships between young people. The production will be predominantly depicted through the eyes of a potential perpetrator. It will explore a young adult relationship where the early signs of abusive behaviour are becoming increasingly present. TURNING offers an insight into what make someone abusive aiming to explore "why do they do that" and further stimulate discussion in a training environment. This is a very useful and innovative way of raising awareness of the issues relating to domestic abuse and reaching young people, giving them some skills and knowledge to be able to protect themselves from this form of abuse"

The production team behind TURNING have previously produced the award-winning, nationally-used training drama "Leaving", which has been found to be an essential part of day-to-day practice in the field of domestic violence awareness and prevention. The production team are looking for support to produce its long awaited and much requested follow-up. The founding funding partner, Family Action, are providing initial financial support but on its own will not be enough to produce the film.

2. Issues for Consideration.

2.1 This resource will provide a further tool to raise awareness around the growing concern and rising figures in relation to Domestic Abuse within adolescent relationships.

2.2 Protecting young people vulnerable to risk taking behaviour and Domestic Abuse is a key objective in the Police and Crime Plan, it is a Force priority on Cumbria Constabulary's Control Strategy and Intelligence requirement.

2.3 The provision of the DVD and training materials will build on and enhance current partnership initiatives:

- Domestic Violence subgroups (Strategic and Operational level) form part of the Safer Cumbria partnership structure. The groups are dedicated to overseeing the work done to prevent, protect and pursue Domestic Abuse.
- Quarterly FISCH meetings (Independent Schools and Children's Care homes)-to share best practise and build relationships with the establishments to improve Safeguarding of some of our most vulnerable children
- Strong partnerships with 3rd sector organisations (Inspira, Barnardos, NSPCC etc)-working together with children to support them and hear their voice.

2.4 The Constabulary and statutory partners have recently completed a Domestic Abuse problem profile a recommendation of which is to *Liaise with partners and OPCC regarding preventative education programmes for schools to raise the profile / increase identification of domestic abuse.'*

2.5 The DV lead for the Constabulary and the Constabulary's School's Officers have agreed that this is a useful resource.
