

# Notification of Disclosable Interests by the Police and Crime Commissioner/Deputy Police and Crime Commissioner

"body in which the relevant person has a beneficial interest" means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;
