**049. APOLOGIES FOR ABSENCE**

## 051. MINUTES

The Chair presented the minutes of the Budget Setting Meeting held on the 22<sup>nd</sup> February 2017 and of the Public Accountability Conference also held on 22<sup>nd</sup> February 2017 which had previously been circulated with the agenda. ## 053. PERFORMANCE FRAMEWORK – Q3 UPDATE

T/ACC Robinson gave a presentation, the purpose of which was to present to the Commissioner the Constabulary's performance for the 12 months to December 2016 as agreed in the Police and Crime Plan Accountability Framework, and in addition to provide statistical estimates for crime levels at the end for this year (2016 – 17) where appropriate and information about user satisfaction performance.

It was noted that the category for All Crime has remained static, while other forces had seen an increase. There is a piece of work ongoing that is looking at why Cumbria is different to other forces.

In the violence against the person category, almost 34% are Domestic Abuse related. This is seen as positive as increased reporting has been positively encouraged. Historic cases (operation Tweed) had also contributed to the increase.

While there had been a small increase in the theft category, burglary had seen a fall. Despite media campaigns, 25% of burglary cases were due to insecure premises – doors left open etc.

Patterns & trends are monitored & interventions put in place accordingly.

The CRASH group sits at County level and scrutinizes road collisions. Targets are set externally and a number of operations are ongoing – eg Bike Safe.

The use of mobile phones in vehicles was discussed, and it was noted that following on from the new legislation 33 tickets had been issued in relation to mobile phone use.

Domestic Abuse had seen a small increase, and is at the heart of vulnerability. There is a partnership approach to support victims – the average length of an abusive relationship is 5 years.

Early intervention can nip DA in the bud and help to change behaviour, and there is a perpetrator programme funded by the PCC in the county to help achieve this.

Body cam is a very useful tool and is used by Officers to record evidence – there is an 85% conviction rate.

#### **054. THEMATIC PRESENTATION – ONLINE CRIME (CYBER CRIME)**

Detective Chief Superintendent Slattery gave a presentation in relation to Online Crime (Cyber Crime).

The purpose of the presentation was to assure the Commissioner that the Constabulary is seeking to address the issue of cyber and online crimes. The internet and its development brings opportunities, but also new and changing threats for crime and criminals, whether for individuals or for businesses and looked in detail at the following areas:-

- Cyber Strategy
- Cyber Dependent/Enabled
- Child Sexual Exploitation/Online Grooming
- The current level and volume of exhibits and investigations impacting on the High-Tech Crime Unit
- The level and types of cyber and economic crime impacting on our county from serious and organised crime groups

It was noted that:-

- In 2016 Cumbria investigated 675 Cyber enabled crimes
- Harassment had consistently been the highest offence type - 44% of all cyber crime since April 2015 when recording began
- The second highest cyber crimes refer to cyber related obscene publications/indecent images – 19%
- 68% of all cyber crimes since April 2015 have involved some form of social media
- 34% of the cyber crime victims were under the age of 18 and 43% were female

It was noted that the Constabulary are currently dealing with 28 long term investigations, the nature of which take a long time & a lot of resource.

Action Fraud deal with fraud cases, making an assessment as to which Force is best to deal with the case, and to look at any emerging patterns. It was noted that there were 110 Action Fraud reports relating to Cumbria.

Malware & ransomware were discussed. Preventative measures can be taken.

#### **055. THEMATIC PRESENTATION – ENSURE OFFENDERS FACE A CONSEQUENCE FOR THEIR CRIME**

T/Superintendent Rutherford gave a presentation which covered the following areas in detail:-

- Community Remedy & Restorative Justice
- Positive Outcomes
- Conviction Rates
- Stop & Search

The Constabulary has sought to increase public awareness of Restorative Justice especially among victims, using the following methods:-

- Force Approach
- Victims First Document
- Community Remedy Work

- Training
- Website

It was noted that the Victims First document is accessible on the website, as well as being given out in hard copy format to victims.

The numbers for Restorative Justice are relatively low. To address this the Constabulary has issued guidance; is looking at supervisor training; is subject to weekly reviews; and working in conjunction with the OPCC. The BIU also has a role to play in terms of compliance & checking. Training awareness & dip sampling is scheduled to take place in June 2017 (using the same methodology as modern slavery to provide re-assurance). National Standards re-affirm training and guidance.

Staff from Remedi attend officer training to raise awareness of RJ – it is acknowledged that this is a partnership issue, not just a policing issue.

Cautions are not an able available option for repeat offenders.

It was noted that Cumbria is placed 9<sup>th</sup> best in the country for out of court disposals, which is above the national average, with an upward trend. 16% of repeat offenders are given an out of court disposal, with gravity matrix standards applied. T/Superintendent Rutherford re-assured the Commissioner that the issue is taken very seriously.

National CPS & Courts data show that Cumbria is placed 1<sup>st</sup> in the Country for conviction rates at Magistrates Court. This has been measured since 2005 and Cumbria has always been placed in the top 5. The picture also translates across for Crown Court.

A more targeted approach has been applied to Stop & Search, and gives re-assurance that this intrusive power is used appropriately.

## **056. ETHICS & INTEGRITY PANEL ANNUAL REPORT**

The OPCC Chief Executive presented the Ethics & Integrity Panel annual report. The purpose of the Ethics & Integrity Panel is to promote and influence high standards of professional ethics in all aspects of policing and to challenge; encourage and support the Commissioner and the Chief Constable in their work in monitoring and dealing with issues of ethics and integrity in their organizations.



The Panel considers questions of ethics and integrity within both organizations and provides strategic advice and support in relation to such issues.

The Panel meet on a quarterly basis, and in the last quarter considered the following items:-

- Civil Claims
- Police Staff Misconduct
- Integrity – Complaints by the Public
- Integrity – Anti-Fraud & Corruption
- Thematic Review – Kendal Calling
- OPCC Complaints & QSPI's

The future work of the Panel was discussed and it was noted that the Panel would initially consider Special Constabulary Recruitment and the Use of Taser with others being presented when required. These areas will be added to the Panel's Annual Work Programme for 2017.
