## 023. FINANCIAL MONITORING REPORT – CONSTABULARY REVENUE BUDGET MONITORING 2016/17 TO SEPTEMBER 2016

The Constabulary Chief Finance Officer provided an overview of the report. There had been a significant improvement due to the pro-active management of the budget.

The current forecast of net expenditure amounts to £108.326m compared to a revised budget of £107.445m. The variance amounts to a forecast overspend of £881k (0.82%) and is made of a forecast overspend on expenditure budgets of £658k (0.58%) and a forecast under recovery of income of £223k (4.02%).

The forecast overspend at September has reduced by £228k when compared to the figure reported as at the end of June of £1.109m. The overspend is made up of overspends on some categories totalling £1.388m which are being partially offset by underspends on others totalling £507k.

Police Officer pay continued to account for the most significant overspend, and was in a similar position to the end of quarter 1. There had been a peak in demand during the summer which was due to annual leave etc.

Some Police Staff vacancies have been held pending review. It was anticipated there will be some savings in this area.

The Deputy Chief Constable provided reassurance to the Commissioner that budgets are scrutinised on a daily basis.

The Commissioner noted that the position needed to be stable going into the Police Funding Formula review, and that the budget will continue to be very challenging. It was noted that the overspend is less than 1% of the total budget.

#### 024. THEMATIC PRESENTATION - CSE

T/Detective Chief Inspector Gemma Hannah gave a presentation on Child Sexual Exploitation (CSE), the purpose of which was to provide the Commissioner with a detailed overview of Child Sexual Exploitation (CSE) within Cumbria over the last 12 months and reassurance with regard to how the Constabulary is addressing this.

The presentation included:-

- Child Sexual Exploitation— A Definition
- The current 'picture' Reports of Child Sexual Exploitation in Cumbria.
- Cumbria Constabularies Response.
- A Case Study

The Nationally agreed definition of **Child Sexual Exploitation** (CSE) used by government agencies is;

Sexual exploitation of children and young people under the age of 18 involves exploitative situations, contexts and relationships where young people (or a third person/persons) receive something (e.g. food accommodation, drugs, alcohol, cigarettes, affection, gifts, money) as a result of performing and/or another or others performing on them, sexual activities. CSE can occur through the use of technology without the child's immediate recognition; for example being persuaded to post sexual images on the internet/mobile phones without immediate payment or gain.

The Constabulary is working together with other regional forces in the North West to develop a regional problem profile. Work is also undertaken with TITAN (the Regional Organised Crime Unit – ROCU).

A monthly tracker shares information with other agencies on young people at risk of CSE. There are 107 young people currently on the tracker, with 57 receiving services across the county regarding CSE. The tracker forms part of the LSCB multi-agency oversight group. Hotspots are identified and task groups create action plans.

The age profile trend is:-

- White girls aged 14 16 are most at risk
- White males aged 16 20 are most likely to offend

More peer on peer offending is being seen, and is likely to occur within dwellings behind closed doors. Online contact is the biggest significant factor. Images can be posted person to person and can be used as a bargaining tool.

When CSE is reported, even if no crime is identified, intelligence will be gathered and a vulnerable child report will be completed and submitted, and will also be shared within the Safeguarding Hub.

It was noted that resourcing has increased in Public Protection, and in the multi-agency Safeguarding Hub since it was introduced in 2012.

Education is key – there have been 48 performances of the Chelsea's Choice play, which was funded by the OPCC.

Two Facebook CSE engagement events have also taken place, with people coming forward for advice or to report concerns.

Brathay Trust provides a wrap-around service in relation to CSE, which was funded by the OPCC.

The Constabulary have also invested heavily in training front line and front counter staff, as well as staff in the Command and Control Room to recognise CSE. Every officer has received specific CSE training. Best practice tools have been identified and a safety plan attached on all police systems.

The Commissioner thanked T/Detective Chief Inspector Hannah, and following a discussion, the presentation was noted.
